

Table Tennis England Selection Policy

v1.0

European Under 13 Championship: Kosta, Sweden: 24th - 28th September 2024

1. Event Purpose

Table Tennis England will select players to this event in order to achieve the following objectives:

Primary Objective

- 1.1 To reach the quarter final or beyond in the Team event;
- 1.2 To Reach last 16 or beyond in the singles event;

Secondary Objective

- 1.3 To provide the opportunity for younger players to gain international experience;

2. Eligibility

Table Tennis England will only select athletes to represent England who:

- 2.1 Are affiliated to Table Tennis England, holding a valid Table Tennis England Player Licence and in good standing;
- 2.2 Are eligible to represent England in ITTF, WTT and ETTU approved competitions and have a valid British Passport;
- 2.3 Are not currently under disqualification or suspension under the rules of Table Tennis England or ITTF & ETTU;
- 2.4 Are not currently serving any sanction for an anti-doping rule violation under any relevant anti-doping rules;
- 2.5 Have provided Table Tennis England with a signed Acknowledgement (as set out at the end of the Selection Policy) **by 9am on 31st June 2025**
- 2.6 Have notified Table Tennis England that they wish to be considered for this event **by 9am on 31st June**. Players are required to notify the Performance Department in writing or by email (performance@tabletennisengland.co.uk), that they wish to be considered for selection by this date;
- 2.7 Are eligible to compete in either the Under 13 age categories. For the avoidance of doubt, players need to have been born on or after the following dates:

- Under 13 - born on or after 1st January 2012

If selected, players may be required to sign a Team Members' Agreement to accept their place at each event. The Agreement will include a code of conduct and a commitment to adhere to observe Table Tennis England sponsorship guidelines and to wear, if required, appropriate apparel.

3. Scope of the Team

Table Tennis England will select through the following selection process;

a. European Under 13 Mixed Team Event

The selection panel will select 2 boys and 2 girls to represent England in this event;

b. European Under 13 Singles Event

The players selected for the Mixed Team Event will also represent England in the Singles Event.

Eligible players will be considered under the criteria set out in point 4 of the policy;

4. Criteria

The selection panel as experts, will use their judgement to select individuals in order to achieve the objectives as set out at the beginning of this policy (point 1). Their reasoning must be rational, reasonable, free of bias and generally in accordance with the principles of natural justice. The panel will consider relevant information from within the qualification period (point 6), in the following priority order:

Primary Criteria

- International Profile based on best results at WTT Contender Events. And European events.
- Current National Champion and significant other domestic results.
- Ranking Trajectory in relevant age category
- Attendance to specified England Futures Camps
- Physical readiness and capability to compete at this level;

Seconday Criteria

- Team Commitment and cohesion
- Current illness or injury status;

5. Medical

At the time of their selection, any selected player may have their medical and/or musculoskeletal status confirmed by a nominated Table Tennis England Medical adviser. Any selected player may, at any other time, be required by the Head of Performance Development (and/or his delegate) to undergo fitness or medical assessments to ensure that they have maintained an adequate level of fitness to perform to the best of their ability. The Head of Performance Development (and/or his delegate) will specify the process by which a selected player is to confirm his or her continued health and fitness, which might include participating in certain events or undergoing fitness tests.

7. Selection Panel

A selection panel will be established comprising:

- Independent Observer (non-voting)
- 2 x Pathway Coach
- Head of Pathway Development

In the event of any conflict of interest for any member, the Table Tennis England conflict of interest policy should be adhered to. Any member with a conflict of interest shall not be entitled to vote on that issue.

8. Team Travel, Supervision & Kit

All selected athletes will be under the supervision of Table Tennis England staff for the duration of the event. In signing this selection policy, players are committing to travelling to and from the event with the team and staying together in the accommodation arranged for the event. England Kit will be issued to all athletes for this event.

9. Media & Communication

All selected players are required to adhere to the Social Media guidance which can be found on the Table Tennis England website at the following address:

All players, whether selected or not are required to keep the notification of their selection or non-selection confidential until directed by the Table Tennis England.

10. De-Selection

Table Tennis England retains the right to deselect any selected player under any of the following circumstances:

- i. The player is no longer eligible for selection for this event;
- ii. The player does not adhere to the code of conduct or team members agreement;
- iii. The player in the opinion of the Selection Panel, is no longer physically or mentally able to perform at the level consistent with that which earned their initial selection;
- iv. The player fails to comply with any reasonable training or competition programme set out by Table Tennis England performance staff;
- v. Any exceptional circumstances exist which in the reasonable opinion of the Selection Panel justify the non-selection or de-selection of the player concerned.

Any player who is de-selected will immediately be notified of the decision and the reason. They will have a right of appeal in accordance with the appeals process.

11. Appeals

Eligible players only have the right to appeal in the following cases:

- i. The criteria was not applied correctly;
- ii. A player was de-selected under Point 9 above;
- iii. An ineligible player was selected under any point.

- i. Selections save for ineligibility;

For any Under 18 players', a parent or guardian will also be required to sign the returned copy. Players' should retain the second copy for their own records.
