This event is restricted to 24 players with entries accepted on a last in first out basis.

Tournament details : Players will be ranked 1-24 based on current computer points
and their known playing standard.

Play will be in 4 groups of 6 followed by banded matches.

Players finishing 1&2 from each group go into band 1, players finishing 3&4 into band 2,
and players finishing 5&6 into band 3.

Players in each of the 3 bands will play a further 3 matches which will decide band placings,
with all players playing 8 matches in total resulting in the final tournament placings 1-24.

CLOSING DATE FOR ENTRIES : Saturday 30th. March 2013.

The draw will take place on 31st. March 2013. No entry will be accepted after the draw has been made.

Acceptance of entry and start time confirmations will be notified by telephone, text or e.mail.

Tournament Regulations & Conditions :

- *This event is open to all male and female players – NO age restriction.
- *Every entrant **MUST** be affiliated as a Player Member to the ETTA Ltd., or be a member of another National Association in membership of the ITTF.
- *ETTA Tournament Regulations apply to this tournament.
- * ITTF Regulations for International Competitions apply except those relating to the matters covered by items marked (x) in this entry form.
- *Completion and submission of this entry form signifies agreement by the entrant to the regulations and conditions of this competition.
- *Each match will consist of best of 5 games, each game up to 11 points with a 2 point difference to decide the winner.
- *All players will be expected to umpire after losing, or when asked to do so by the organiser.
- * The main colour of clothing must be different from the colour of the ball.
- *Players will be expected to play when called, so do not leave the venue at any time without the organiser's permission.
- ***ALL** players will be expected to honour fully their playing and umpiring commitments/obligations. Should any player fail to do so, that player will be suspended from entering any further Suffolk grand prix events for a period of 12 months as from the date of suspension.
- * If you enter and subsequently are unable to play, you **MUST** notify the organiser as soon as you know that you cannot attend as a reserve player can then be arranged. Someone not turning up on the day without notification can disrupt and spoil it for everybody.
- *All fees are non-refundable unless otherwise stated.
- *No competitor or Official shall engage in betting on players matches.
- *Doping shall not take place either before or during play.
- *'Knocking' on vacant tables between matches will be at the discretion of the organiser(s)/referee(s).

Playing Conditions :

- *Play will be on 3 Donic tables with Donic posts and nets.
- *Each table will be in an individual court enclosed by surrounds.
- *Each court will be 5.67metres wide by 11 metres in length.
- *Minimum height of playing area is 3.5 metres.
- *Minimum height of lighting from floor is 3.75metres
- *Lighting is general and by fluorescent and halogen-quartz.
- *Flooring, solid with plastic surface.
- *There are no practice facilities.

General Information :

- *No assistant umpires will be appointed for matches.
- *Score machines will be used for all matches.
- *Balls used will be white Butterfly 3*.
- *Doping control tests may take place.
- *Prize fund allocation :
 - Band 1 - Winner £130, Runner-up £70, 3rd. £30, 4th. £15.*
 - Band 2 - Winner £25 voucher , Runner-up £10 voucher.*
 - Band 3 - Winner £25 voucher , Runner-up £10 voucher.*

[If less than 24 players enter then the prize fund will be reduced accordingly]
